# Notice Concerning Decision on the Intra-group Reorganization Plan

The Company group (the Company and its consolidated subsidiaries; hereinafter "Nintendo") would like to announce that it has passed a policy to reorganize the companies in Europe.

Since our wholly owned subsidiaries (and sub-subsidiary) are the parties of reorganization, some of the matters and details required for timely disclosure are omitted.

#### 1. Purpose of the reorganization


Nintendo has subsidiaries in several countries in Europe and conducts its business tailored to each country. For the purpose of improving business efficiency and accelerating decision-making by consolidating functions into Nintendo of Europe GmbH (hereinafter "NOE"), the other subsidiaries in Europe will be merged with NOE. In the course of reorganization, NOE's corporate form will be changed to Nintendo of Europe SE as the new central regional headquarters in Europe.

#### 2. Overview of the reorganization

Nintendo will conduct an absorption-type merger in which our subsidiary NOE shall be the surviving company, and Nintendo France S.A.R.L (hereinafter "NFR"), Nintendo Benelux B.V. (hereinafter "NBX") and Nintendo Ibérica, S.A. (hereinafter "NIB"), which are also our subsidiaries, will be the disappearing companies. The merger of NFR and NBX is scheduled for July 2023, and the merger of NIB is scheduled for August 2024. The business of these three merged companies will continue at each of the newly established branches.

In addition, Nintendo plans to change NOE's trade name to Nintendo of Europe AG in January 2024 and Nintendo of Europe SE in August 2024.
